Now the condition of the above written bond is such that the said

which the said person shall have no control (the opinion of the Forest  
Department as to be existence of such circumstances being final to  
undergo the full period of training as prescribed in G.O.Ms.No.3669 Public  
(Training-II) Department Dated 23.11.1974 and G.O.Ms.No.3053, Public  
(Training) Department, Dated 23.09.1975 at the Civil Service Training  
Institute, Bhavanisagar and shall during such period of training abide by  
such rules as may from time to time be laid down by the Government, or  
the Principal, Civil Service Training Institute, Bhavanisagar or competent  
authority for regularizing the course of training attendance and conduct  
and shall not during courses of training be guilty of idleness, misconduct  
or irregularity in attendance and shall at the times obey and follow the  
orders and directions that may from time to time be given by the  
Government, or the Principal, Civil Service Training Institute,  
Bhavanisagar or the Forest Department or other person duly authorized in  
the behalf, on completion of her training, she shall, sit for the examination

conducted by the Principal, Civil Service Training Institute, Bhavanisagar and pass it. She agrees that she is bound to serve the State Government for a period of not less than five years at the date of completion of training as \_\_\_\_\_ (*designation*) in the Department and in the said \_\_\_\_\_ (*candidate name with designation*) shall in the event of failing to observe or perform all or any one or more of the convenient and conditions herein before contained refund to the Government on demand the sum actually drawn as pay and allowances by the said \_\_\_\_\_ (*candidate name with designation*) during the period of her training.

The above written bond or obligation shall be valid and it shall remain in full force. The sum of Rs.50,000/- (Rupees Fifty thousand only) under the bond may be recovered under the Madras Revenue Recovery Act 1864 (Madras Act II of 1864) as it were in arrears of Land Revenue without prejudice to any other mode of recovery.

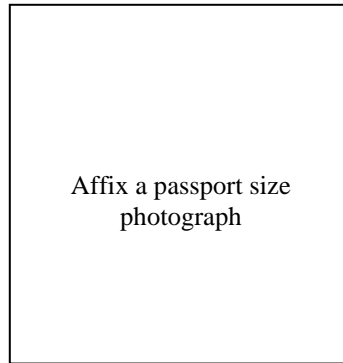
