ORDER:

In the Government Order first read above, orders were issued fixing the rate of interest for the accumulation at the credit of the subscribers to the Contributory Pension Scheme at **7.6%** (Seven point six per cent) for the period from 1st April, 2018 to 30th June, 2018.

2. In the Government Order second read above, the rate of interest for accumulation at the credit of subscribers to the General Provident Fund [Tamil Nadu] were fixed at the rate of **7.6%** (Seven point six per cent) with effect from 1st July, 2018 to 30th September, 2018.

3. The Government now direct that the rate of interest on the accumulation at the credit of the subscribers to the Contributory Pension Scheme shall carry interest at the rate of **7.6%** (Seven point six per cent) with effect from 1st July, 2018 to 30th September, 2018.
