

ABSTRACT

Telephones – Ceiling on free calls prescribed to residential telephones of Government Officers – Inclusion of charges for additional facilities like broadband and procedure for calculation of eligible amount to officers – Sanctioned - Orders Issued.

In the Government Order third read above, orders were issued prescribing the ceiling on free calls to the residential telephones of various categories of officers of the State Government as detailed below.

Categories	Ceiling	Officer entitled for the facility
Category - I	Total exemption (No ceiling on free calls)	High dignitaries / Officials mentioned in Annexure I to the Government Order
Category -II	1000 (one thousand) free calls monthly including the free calls allowed by BSNL	Secretaries to Govt. Including Additional Secretaries to Government and other officials given in Annexure II to the Government Order
Category-III	500 (five hundred) free calls monthly including free calls allowed by BSNL	Certain Heads of Department/ Gazetted Personal Assistants/ Senior Personal Assistants to Ministers and other officials given in Annexure III to the Government Order
Category- IV	300 (three hundred) free calls monthly including free calls allowed by BSNL.	All other officers who are not covered in Annexures I,.II, III to the Government Order

2. Based on the above Government Order, at present, the charges for the calls made over and above the ceiling fixed are recovered from the concerned officers and credited to the relevant head of account by the concerned Departments. The excess call charges are calculated based on the metered calls and the calls allowed to the officer. Earlier, BSNL used to bill the subscribers based on a single billing plan and there were no problems in calculation of

recovery of excess call charges from officers. Later when BSNL started introducing various billing plans, uniformity in recovery of excess call charges could not be maintained, since the amount to be recovered from officers varied in each case, according to the billing plan. In the reference second read above, a procedure for calculation of excess call charges to be recovered from the officers, based on ceiling amount, was prescribed. Various clarifications on the calculation of excess call charges recovery are sought by the Departments of Secretariat and Heads of Departments time and again. Besides, requests for broad band facility to their residential telephones are also received from many officers.

3. In the reference fourth read above, the Deputy Secretary to Government, Finance Department has requested the Government to switch over to the fixed amount based ceiling instead of the calls based ceiling. He has also requested to permit the officers to select the service providers of their choice and also to avail additional facilities like broad band within the maximum ceiling amount prescribed by Government without any additional expenditure to the exchequer. Due to technological advancements in the field of telecommunications, internet facilities are in widespread use among the officers, departments and the common people. Most of the departmental works are being computerised and as such facilities such as broad band at office and residence have become very essential.

4. This Department has proposed to calculate the eligible call charges in respect of the residential telephone of the officers, as per the orders issued in G.O. Ms. No. 1125, Public(Telephones.I) Department, Dated 3.10.2008, based on amount based ceiling instead of call based ceiling as follows:-

5. The Government after careful consideration direct that the call based ceiling system shall be substituted by the amount based ceiling for calculation of call charges in respect the residential land line telephones of officers as follows:-

The officers shall be permitted to choose any telecom service provider / any package and avail any other value added services along with the land line within the maximum monetary ceiling allowed to them for their residential telephones, for which bills are settled by Government. The charges related to hiring/purchase of equipment shall be borne by the concerned officers. The above orders shall take effect from the date of issue of this order.

6. The Departments of Secretariat are requested to follow the procedure on para 5 above, while settling the residential telephone bills of their officers from the subsequent bills, received after the issue of this order and the same shall not be applicable to old bills. 7. The list of officers for whom ceiling on free calls to the residential telephones has been fixed in G.O. Ms. No. 1125, Public (Telephones.I) Department dated 3.10.2008 is annexed to this order for ready reference.
