### ORDER:-

In the Government Order first read above, the Government have sanctioned three posts of Advocates to the Forest Department, to strengthen the Legal Cell.

2. In the Government order second read above, orders have been issued changing the nomenclature for the three posts of Advocates as Additional Legal Officer. The issue of Adhoc/Special Rules for the above said posts is under examination.

3. In the Government order third read above, to engage three Advocates on contract basis for a period of six months, (two for Chennai and one for Madurai) at consolidated wages of Rs.40,000/- per month to provide legal assistance for the various litigation in Forest Department and sanctioned a sum of Rs.7.20 lakhs for a period of six months.

4. In the letter fourth read above, the Principal Chief Conservator of Forests has appointed 3 persons as Additional Legal Officers on 22.02.2021 based on the Government order 3<sup>rd</sup> read above out of Rs.7.20 lakhs released for the year 2019-2020, no expenditure was incurred. Three persons (2 for Chennai and 1 for Madurai) appointed as Additional Legal Officers have joined on 22.02.2021.

5. The Principal Chief Conservator of Forests has therefore requested the revalidation orders for an amount of Rs.7.20 lakhs sanctioned to engage three advocates on contract basis for a period of six months (two for Chennai and one for Madurai) at consolidated wages of Rs.40,000/- per month to provide legal assistance for the various litigation in Forest Department.

6. The Government after careful examination, accept the request of the Principal Chief Conservator of Forests, Chennai and revalidate an amount of Rs.7,20,000/- (Rupees Seven Lakh and Twenty thousand only) sanctioned to engage three Advocates on contract basis for a period of six months, (two for Chennai and one for Madurai) at consolidated wages of Rs.40,000/- per month to provide legal assistance for the various litigation in Forest Department for a period of six months.

7. The expenditure sanctioned above shall be debited under the following head of account:-

"2406 – Forest and Wildlife – 01 – Forestry 001 – Direction and Administration – State's Expenditure – AA – General Direction – 333 – Payments for Professional and Special Services – 04 – Contract payment

8. Necessary additional funds of Rs.7.20 lakh will be provided in RBE/RE/FMA 2021-2022. Pending provision of such funds, the Principal Chief Conservator of Forests is authorized to draw and utilize the amount sanctioned in para 6 above. The Principal Chief Conservator of Forests is directed to include this item expenditure while sending the proposal for RBE/RE/FMA 2021-2022 to Government in Finance (AHD & F) Department without fail.
